Rock Your Home Hospital Birth Initiative

Amanda Gilman, RN, IBCLC, owner of The Mama Coach in NH, is spearheading an innovative prenatal education project called "Rock Your Hospital Birth" to foster stronger connections between community hospitals and birthing populations. The initiative's mission aims to improve Maternal Child Health outcomes ensuring every birthing person has access to evidence based prenatal education and community resources in pregnancy despite their location. socioeconomic status. lifestyle, or schedule. Amanda seeks collaboration with hospitals organizations committed to enhancing maternal child health outcomes and resource sharing, and recognizing the value of offering families a modern, convenient avenue for accessing crucial information and resources to thrive in the postpartum period. The course is being developed by Amanda, a seasoned local RN, and can be tailored to meet the specific needs of community health organizations and families. 
Recap

On March 4, 2024 over 200 NH maternal health partners met in Concord NH for the launch of the New Hampshire Perinatal Quality Collaborative, to discuss the NH Maternal Health Report data, and to discuss perinatal health in our communities.

The Summit saw representation from diverse perinatal partners including OBGYN and Pediatric doctors and nurses, doulas, midwives, home visiting, social services, and mental and behavioral health. Community member attendees included birthing people, leaders grassroots initiatives, and leaders of diverse NH populations. The breakout sessions identified local perinatal concerns including navigating access resources, confronting substance use literacy and education, transportation services, postpartum care and doula services. After reviewing the NHPQC's Mission, Vision, Goals, and Strategic plan Summit attendees suggested adding initiatives around legislative advocacy, more mental health

resources, frontline worker burnout, and discrimination, stigma, unconscious bias resulting inequities in standards of care. One Summit attendee commented, strength of the Summit was the conjoined knowledge faculty/speakers had, and willingness to hear a variety of different perspectives openly and respectfully". The NHPQC hopes to continue this momentum by meeting with each community to develop infrastructure including support learning collaboratives, maternal safety workgroups, and resource sharing initiatives. We are still actively working through your Summit feedback and will present this data further in subsequent Newsletters and regional meetings.
